• INTEGRATED PROGRAMMES WITH SPANISH STUDENTS (PI)

Each programme consists of regular degree courses taken alongside Spanish students (see programme designations below).

- If a student wishes to take classes taught in English, the home university should make sure the student has a minimum level of B2 in English.
- Students will choose courses from only one programme, which will take place at one of the following campuses Madrid-Princesa o La Berzosa depending on the area of study.

It is important to remember that it is only permitted to select modules / classes from a single Integrated Program, and that the final availability of timetables and confirmation of your classes only takes place through an auto-enrollment process a few weeks before classes start.

For your provisional course selection, you are **required to select 10 possible** courses in order of preference (in case changes are necessary due to spot limitations or timetable conflicts). Who is the entity's Data Protection Delegate (DPD) and how can he/she help you?

The DPD is a figure, legally foreseen, that has as its main duties to inform and assess our entity regarding the obligations that affect it in regards to the protection of personal data, and to supervise its compliance.

Additionally, the DPD acts as a point of contact for any questions related to the treatment of personal data, so that, if there are any such consultations, doubts, or recommendations in regarding the same, you may direct your queries to him/her: DPO@nebrija.es.

For what purpose do we process your personal data?

Personal data is treated to manage admissions applications and to answer queries relating to it, in addition to, if applicable, to process the enrollment in the requested program, to provide corresponding education services for this program, and to manage whatever activity / activities related to the same.

It is obligatory that the interested party provide the requested data since, otherwise, it would not be possible to manage the petition for admission, nor the enrollment to the requested program, therefore being impossible to become admitted to UNIVERSIDAD NEBRIJA.

Similarly, if the interested party demonstrates his or her consent, their data could be used to facilitate information about our services, offers, and events through whichever means of communication. The submission of your data towards this end is voluntary, although should you not indicate your consent, you would in that case not be a recipient of these communications.

For how long will we treat your data?

Your data will be conserved until the process of admission is finalized or, in case of being admitted, until the end of the requested program and, even after, until the required and related eventual responsibilities are resolved that are derived from the academic relationship maintained with this University during the full period of time required by the applicable regulations. That being said, your data could be conserved indefinitely with the end of sending commercial communications, unless you oppose the same by indicating so to whichever points contact provided.

What is the legitimacy for the processing of your data?

The basis for the treatment is the application of pre-contractual measures in order to evaluate your request and respond to you regarding in accordance to the realization of the selected program at this University. For the sending of commercial communications, your data will be treated based on your consent, of which you may revoke at any time, although this would not affect the legality of data already previously treated. With relation to the sending of the previously referred-to communications, based upon the provided information, we may create commercial profiles in order to offer you products and services that best adjust to your interests.

To which recipients will your data be communicated?

Your data may be provided to the Public Administration in those cases foreseen in the Law and towards the finality defined therein. Similarly, if the interested party has manifested their consent, their identification and contact details would be provided to Residencias Nebrija towards the end of this entity providing, through whatever communication means, information regarding the services it offers. Your consent can be revoked at any time without affecting the legality of data previously managed.

If the student requests the Intensive Preparatory Course in Spanish Language, their data would be provided to Institutos Nebrija, the entity which is charged with providing said course. In case of the admission of the student, this management of data will be based on complying towards an objective done for public interest, in virtue of the current education legislation, as with the execution of the contractual relationship maintained with the student, with respect to those services requested by the student to Institutos Nebrija that are not directly related to the public service of education.

Similarly, in the supposed case that a student comes from another institution as a consequence of an agreement of collaboration signed with the same, their data could be communicated to the institution of origin to inform on the admission of the student, and for follow-up any academic studies done for its control and recognition. These institutions could be located outside of the European Economic Space, which implied a transfer of international data in compliance with article 49.1 B) of the GDPR: the transfer that would be necessary for the execution of a contract between the interested party and the entity responsible for the treatment, or for the execution of pre-contractual measures adopted due to the request of the interested party.

What are your rights when you provide us with your data?

You have the right to request access to your personal data, their modification or elimination, as well as the limitation of its treatment, to oppose the same and its transference, using the forms provided by the University at the following webpage <https://www.nebrija.com/general/formularios.php>. For any possible eventual violation of your rights, you may present a claim to the Spanish Agency for Data Protection (www.aepd.es). In case personal data of a third party has been provided, it is the exclusive responsibility of who obtained this information previously with the consent of said person so that this data is then managed by UNIVERSIDAD NEBRIJA, having been necessary to have previously informed said person of the legislation in article 14 of the General Data Protection Regulation.
